Accordingly, the mandatory requirements are hereby clarified as follows:

5	Bidders must possess a valid Fidelity Fund Certificate issued by the PPRA or an equivalent recognised regulatory body in South Africa, where applicable, authorising them to lawfully trade and receive income.		

This notice serves as a **clarification and rectification** of the mandatory specification requirements only. The purpose of this clarification is to ensure that all bidders who hold equivalent professional registrations and certifications issued by recognised bodies in South Africa are afforded an equal opportunity to participate in this procurement process.

There are no changes to the bid closing date, time, or submission venue. The bid will therefore close on **22 July 2026 at 12:00**, as originally advertised.
